Request to Discontinue Analysis of Ground Water for PCBs

Dear Mr. Valerian:

On August 16, 2012, the Ohio Environmental Protection Agency (Ohio EPA), Northwest District Office (NWDO), received a document titled, "Request to Discontinue PCB Analysis of Groundwater" (request), dated August 15, 2012, for the Sunny Farms Landfill (Facility). The request was prepared by Civil & Environmental Consultants, Inc. The owner/operator seeks permission to discontinue analysis of ground water for the presence of PCBs.

On March 1, 1994, Ohio EPA issued Permit To Install (PTI) Number 03-6324. PTI condition number 17 states:

"The permittee shall analyze the ground water annually for the presence of PCB. This constituent shall be sampled and reported in accordance with the sampling and analysis plan in the PTI. The sample shall be analyzed in accordance with an SW-846 test method preapproved by the Ohio EPA."

The August 15, 2012, document concluded that other Ohio municipal solid waste landfills that accept waste streams similar to the Facility are not required to analyze ground water for the presence of PCBs. Further, PCBs have never been detected above the laboratory Practical Quantitation Limit (PQL) in the ground water or in the annual leachate grab sample required to be analyzed for PCBs pursuant to OAC Rule 3745-27-19(M)(5) since 2003.

Ohio EPA concurs with your request and, pursuant to the authority in OAC Rule 3745-27-02, PTI Number 03-6324 is hereby modified such that Sunny Farms Landfill, LLC may discontinue analysis of ground water for the presence of PCBs. This authorization supersedes Condition Number 17 of PTI Number 03-6324, issued on March 1, 1994.

You are hereby notified that this action of the Director of Environmental Protection (Director) is final and may be appealed to the Environmental Review Appeals Commission pursuant to Ohio Revised Code Section 3745.04. The appeal must be in writing and set forth the action complained of and the grounds upon which the appeal is based. The appeal must be filed with the Commission within thirty (30) days after notice of the Director's action. The appeal must be accompanied by a filing fee of \$70.00 made payable to "Treasurer, State of Ohio." The Commission, in its discretion, may reduce the fee if by affidavit it is demonstrated that payment of the full amount of the fee would cause extreme hardship. Notice of the filing of the appeal shall be filed with the Director within three (3) days of filing with the Commission. Ohio EPA requests that a copy of the appeal be served upon the Ohio Attorney General's Office, Environmental Enforcement Section.
